Course Description and Objectives

Social science courses should help us to understand where we have been, where we now stand, and possibly, where we are heading as a society. Accordingly, this course has two emphases: social change (major historical transitions in society) and corresponding family changes. In this course, we will investigate historical changes in family life from the clan family to the patriarchal family, the nuclear family and the proposed present day “post nuclear family.”

There are four main objectives to this course. First, you will learn the basic concepts used in the study of human societies and the most fundamental building block of society – the family. Second, you will be challenged to adopt a sociological imagination and understand the structural and cultural limitations that create and limit individual opportunities and choices and shape families. In other words, individuals are not necessarily capable of doing whatever they choose, even if they try hard enough. Social structures help to determine what is possible. Third, you will be able to use critical thinking to evaluate information about family and social problems and to understand why some social issues become defined as problems while others do not. Fourth, you will be able to apply a critical consciousness to events that take place in your everyday life.

The course fulfills the University’s “diversity in Western experience--y” multicultural requirement and is a Women’s Studies course, so issues of race/ethnicity and gender are highlighted throughout.

Required Reading

Students are expected to read assigned material before the class in which the topics are covered. You should purchase the following *required* textbook:

Class Communication – Email and Course Website

Course Requirements:

Your final grade will be based on the quality of your performance with respect to the course assignments and responsibilities. The allocation of points is as follows:

- (1) Online Bio – 5%. You will receive five points for completing a brief “quiz” during the first week of class. This online quiz covers questions about your background, interest in the course and whether you agree to the policy statements explained in the College of Social Sciences Policy on Student Conduct. Before you begin the online bio, please read the policy statement available at <http://e-soc.net>.
- (2) Three Group Discussions – 30%. At three points in the semester, a discussion topic will be posted on the course website discussion board located on Blackboard. Each student is expected to post a 150 word position statement, in essay form, to the discussion topic and to post two 50-75 word replies to other students’ statement postings. Based on the relevance and quality of your posts, you can earn a possible 10 points for your contribution in each group discussion. There will be *no credit given for late postings on the discussion board or for “flaming” and other inappropriate responses*. Remember, to receive full credit for each group discussion, you must *post three times*: a position (not opinion) statement with a 150-word minimum and at least two reactions with a 50-75 word minimum by the deadlines posted on the syllabus. Participation in online group discussions together will comprise 30% of your grade.
- (3) Three exams – 65%. The three exams will cover material from assigned readings and materials covered in class. Students should take class notes. Topics discussed in class will generally parallel material in the Cherlin text; however, I will bring information into the lecture that does not come from the text. You are responsible for information presented in the classroom, the text and other assigned readings covered during the course. Each exam will cover a third of the course. The exam dates are listed in the course calendar. **The final exam must be taken on the scheduled date – December 10 at 7:30am.** Please save the date.
